4.1 2021 Traffic Calming Project Updates

The Committee reviewed different types of traffic calming devices for future. The Public Works Road Supervisor noted that the Thornton Crossing crosswalk had been installed and is almost ready for use. RFB's for the Sydenham Crossing and Auburn Crossing have been ordered and are scheduled to be installed before the start of the 2021/2022 School year.

4.2 Traffic Calming Locations Summary

The Roads Supervisor for Public Works spoke to this. Speed bumps, radar signs and traffic counters have been installed. Our supplier is delayed due to Covid. Remaining traffic calming areas will be addressed once supply has been restocked.



## 4.3 2021 Traffic Counts – Speed Analysis

Traffic Counts were analyzed, and locations were added for speed calming measures. Locations that had speed bumps installed noticed a drastic reduction in speeds and infractions

The above noted concerns were discussed by the Committee and speed data will be collected in the concern areas to assist in determining best traffic calming measures needed. O.P.P. will heighten patrols for the suggested areas. Speed bumps have been delayed due to Covid issues with Suppliers.

#### BY-LAW NO. 2021 - 36

## Being a By-law to provide for the Prohibition of Certain Noises and to amend By-law 2018-47.

WHEREAS the *Municipal Act*, 2001 S.O., c.25, Sec.128(1), provides that a local municipality may prohibit and regulate with respect to public nuisances, including matters that, in the opinion of Council, are or could become or cause public nuisances; and

WHEREAS the *Municipal Act*, 2001 S.O., c.25, Sec.129(1), provides that a municipality may pass by-laws to prohibit and regulate noise, vibration, odour, dust and outdoor illumination; and

WHEREAS Council of the Corporation of the Township of Essa repealed By-law 2005-66 on June 6, 2018 thereby replacing it with By-law 2018-47, that being a By-law to provide for the prohibition of certain noises during restricted times; and

WHEREAS at its meeting of September 1, 2021, Council directed staff to amend further By-law 2018-47 in an effort to provide for clarification in respect to noise caused by the discharge of firearms; and

WHEREAS section 130 of the Municipal Act comes into force and effect on September 19, 2021, and works to restrict the ability of municipalities to regulate noise caused in connection with the delivery of goods to specified places, except as otherwise authorized by regulation; and

WHEREAS Council of the Township of Essa deems it advisable to amend By-law 2018-47 to include provisions under Section 3.1 "Exemptions" specific to noise related to the delivery of goods to the following destinations;

- 1. Retail business establishments;
- 2. Restaurants, including cafes and bars;
- 3. Hotels and motels; and
- 4. Good distribution facilities.

NOW THEREFORE Council of the Corporation of the Township of Essa hereby enacts as follows:

1. That Section 2.1 (f) be amended to strike the following:

#### ..... or to agricultural operations in the protection of livestock

- 2. That Section 3.1 of By-law 2018-47 be and is hereby amended to include the following provision under "Exemptions":
  - g. Does not apply to noise related to the delivery of goods to the following destinations:
    - 1. Retail business establishments;
    - 2. Restaurants, including cafes and bars;
    - 3. Hotels and motels; and
    - 4. Good distribution facilities.

#### 3. That Schedule A point 1 to By-law 2018-47 be amended to read as follows:

	Prohibited Activity	Prohibited Period of Time
1.	Discharge of Firearms in residential area	At all times

4. This By-law shall come into force and effect on the day it is finally passed.

## A By-law to amend the Township's Zoning By-law No 2003-50, as amended, affecting 203 Barrie St., Thornton.

WHEREAS pursuant to Section 34 of the Planning Act, R.S.O., 1990, Chapter P.13, as amended, By-law No. 2003-50, as amended constitutes the Zoning By-law for the Township of Essa and was passed to control the use of lands, buildings and structures; and

WHEREAS the Council for the Corporation of the Township of Essa is in support of an application to rezone the subject property, legally known as Part Lot 16 & 17, Concession 11, and municipally known as 203 Barrie Street, to a Community Commercial Special (C1-2) Zone to permit a commercial building with medically related office uses; and

WHEREAS the Council for the Corporation of the Township of Essa deems it appropriate, and in the public interest, to pass an amendment to the aforesaid Zoning By-law No. 2003-50, as amended; and

WHEREAS the matters herein as set out conforms to the Official Plan of the Township of Essa.

NOW THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the Township of Essa hereby enacts as follows:

- That Schedule "C" of By-law No. 2003-50, as amended, is hereby further amended by changing the zoning on the property legally known as Part Lot 16 & 17, Concession 11, and municipally known as 203 Barrie Street of the Township of Essa, from Residential Low Density Detached (R1) Zone to Community Commercial Special (C1-2) Zone, as shown on the Schedule "A" attached hereto.
- 2. That Section 19.4, Special Provisions of By-law 2003-50, as amended is further amended by adding Section 19.4.2 as follows:

"19.4.2 C1-2: Part Lot 16 & 17, Concession 11, 203 Barrie Street

Notwithstanding Section 18, General Provisions for Commercial Zones, on lands zoned C1-2 Zone, a landscape buffer to road allowance of 2.3 m is permitted. All other applicable provisions of the C1 Zone contained in Section 18 shall apply.


Notwithstanding Section 30, Non-Residential Zone Regulations, on lands zoned C1-2 Zone, a minimum lot area of 3000.0 m<sup>2</sup> with partial or private services is permitted. All other applicable regulations of the C1 Zone contained in Section 30 shall apply.

- 3. That Schedule "A" is hereby declared to form part of this By-law.
- 4. That this By-law shall come into force on the date of passage and take effect after the last date for filing a notice of appeal where no notice of appeal is filed, or, where a notice of appeal is received, upon approval of the Ontario Land Tribunal, and, in either case, in accordance with the provisions of Section 34 of the Planning Act, R.S.O. 1990, Ch. P.13, as amended.

#### **THE CORPORATION OF THE TOWNSHIP OF ESSA**

#### **BY-LAW 2021 – 38**

#### Being a By-law to provide for the regulation of vehicle parking, standing and stopping on highways or parts of highways under the jurisdiction of the Corporation of the Township of Essa; and, to amend By-law 2005-96.

WHEREAS Section 27 (1) of the *Municipal Act, 2001*, S.O. 2001, c.25 provides that a municipality may pass by-laws with respect to highways over which it has jurisdiction, including the authority to regulate parking on highways; and

WHEREAS Section 35 of the *Municipal Act, 2001* provides that a municipality may pass by-laws removing or **restricting the common law right of passage by the public over a highway** and the common law **right of access to the highway by an owner of land abutting a highway**; and

WHEREAS Sections 63 (1) and 101 of the *Municipal Act* allows for the removal and impounding or restraining and immobilization of vehicles placed, stopped, standing or parking on a highway or on private land in contravention of a municipal by-law regulating vehicles; and

WHEREAS the Council of the Township of Essa deems it desirable to restrict commercial and heavy vehicles from parking on local and collector roads at all times, regardless of signage, in order to allow for the safe passage of pedestrians and motor vehicles, including school buses, emergency vehicles and road maintenance equipment;

NOW THEREFORE the Council of the Corporation of the Township of Essa enacts as follows:

- 1. That section **1** of By-law 2005-96 be amended to strike the definitions for "Commercial Vehicle" and "**Tr**ailer".
- 2. That section 1 of By-law 2005-96 be amended to include the following definitions:
  - a. "Collector Road" means a road that serves to collect and distribute traffic between local streets and arterial roads, with typical daily motor vehicle traffic volurne between 2,500 to 8,000 vehicles per day, with lower speeds (40-50 km/h).
  - b. "Local Road" means a road that serves primarily to provide access to properties and serve a relatively minor role in carrying motorized traffic, with typical motor vehicle traffic volume of less than 2,500 vehicles per day, with lower speeds (40-50 km/h).
  - c. "Road Right-of-Way" shall mean a type of easement granted or reserved by the municipality on all roads within the municipality including the driving surface (paved and/or gravel) and beyond the driving surface over the land for transportation purposes.

3. That section 13 be stricken and replaced with the following:

#### 13. COMMERCIAL, LARGE MOTOR VEHICLE, HEAVY MOTOR VEHICLE AND TRAILERS – PARKING PROHIBITED WITHIN ROAD RIGHT-OF-WAY, LOCAL, AND COLLECTOR ROADS REGARDLESS OF SIGNAGE

- **13.1** For the purposes of this section, the following definitions apply:
  - a. "Commercial Motor Vehicle" means a motor vehicle, **used or intended to be used for commercial purposes**, having permanently attached thereto a truck or delivery body licensed as such by the Ministry of Transportation and without limiting the generality of the foregoing includes ambulance, hearses, casket wagons, fire apparatus, police patrols, motor buses, and tractors used for hauling purposes on the highways. Includes the following even if it does not have a truck or delivery body attached to it:
    - *i.* a motor vehicle commonly known as a tow truck;
    - ii. a mobile equipment vehicle (ie: Road Building Machines as outlined in O. Regulation 398/16); and
    - iii. a vehicle built on a truck chassis.
  - b. "Heavy Motor Vehicle" means a commercial vehicle having a weight when unloaded of 3 tonnes or more, or a weight when loaded of 4.5 tonnes, but does not include an ambulance, police, fire, emergency or utility vehicle.
  - c. "Large Motor Vehicle" means any motor vehicle having an overall height greater than 3.2 metres or overall length greater than 7.5 metres, and includes recreational vehicles such as RVs, campers, trailers, etc.
  - d. "Trailer" shall mean any a vehicle that is, at any time, drawn upon a highway by a motor vehicle, except an implement of husbandry, mobile home, another motor vehicle or any device or apparatus not designated to transport persons or property, temporarily drawn, propelled or moved upon such highway, and except a side car attached to a motorcycle, and shall be considered a separate vehicle and not part of the motor vehicle by which it is drawn, regardless of being loaded or unloaded.
- 13.2 No person shall park or stop, or permit to remain parked or stopped, any commercial motor vehicle, large motor vehicle or heavy motor vehicle on any local road or collector road as outlined in Schedule B of By-law 2005-96.

#### 13.2.1 EXCEPTIONS

Section 13.2 does not apply where:

- a. a Road Occupancy Permit has been applied for and obtained from the municipality.
- b. The commercial, large or heavy vehicle is engaged in works undertaken for, or on behalf of the municipality, with permission having been granted by the municipality.
- c. the commercial, large or heavy motor vehicle or trailer is engaged in making a delivery to, or a collection from, a premises which cannot be reached except by way of a highway or a portion of highway referred to in the said section, or to prohibit the use of such vehicles for such purpose, provided that in making such delivery or collection, the said highway or portion of a highway is





travelled only insofar as is unavoidable in getting to and from such premises. Not to exceed five (5) hours on any road.

13.3 No person shall park or stop, or permit to remain parked or stopped, any trailer on any local road or collector road, at any time, as outlined in Schedule B of Bylaw 2005-96.

#### 13.3.1 EXCEPTIONS

Section 13.3 does not apply where:

- a. A Road Occupancy Permit has been applied for and obtained from the municipality.
- b. The trailer is engaged in works undertaken for, or on behalf of the municipality, with permission having been granted by the municipality.
- 4. That Set Fine provisions contained in By-law 2005-96 be amended as outlined in Schedule B to this By-law.
- 5. That Schedule A as attached to this By-law form part of By-law 2005-96 and be labelled as "Schedule B Prohibited Parking Road Right-of-Way, Local and Collector Roads".
- 6. That this By-law shall come into force and effect on the day it is finally passed.
- 7. That By-law 2005-96 be and is hereby amended.




