Hi Colleen,

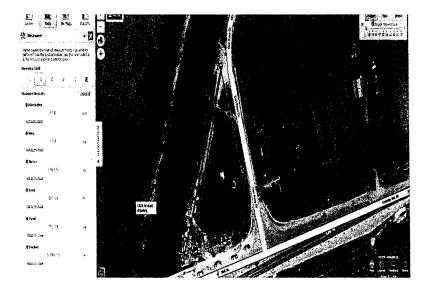
At the special budget meeting of Council of December 1, 2021, comments were directed to the Manager of Parks that Council would like to see the Don Ross Guard Rail Project extend the entire property boundary lines of the Don Ross Fishing Park (Mill St at the south and property boundary line to the north). [Reminder that this is recommended to ensure for safety at the Fishing Park]

The reason only a portion was going to initially be completed in 2022 was to keep within budget limits for 2022 (to keep costs down). Upon completing revisions, the expected length of guard rail has now changed to a total of approximately 139 metres in length, and the cost has changed from \$20,000 to now an expected budget of \$30,000.

BACKGROUND

Council received staff budget presentations and reviewed the draft budget on December 1st, 2021.

COMMENTS AND CONSIDERATIONS

The 2022 draft budget represents an increase of 2.0% which equals approximately \$26.09 per \$500,000 of residential assessment.

There have been some changes made since the December 1st, 2021, budget meeting, they are as follows:

Change in write-offs from the Base (\$46,426) Operating budget changes \$33,057 Revenue changes (\$97,893)

At this time due to the changes made to the 2022 Draft Budget we have also transferred \$111,262.00 into the Special Projects Reserve for Council's consideration.

SUMMARY/OPTIONS
