To all Ontario Municipalities, AMO, ROMA and FCM:

Re: Bill 5 - Risks to your communities and support requested

As Mayor of the Municipality of Chatham-Kent, I am sharing this motion to bring to your attention the potential risks to your communities and ask for your support to oppose this approach. The following motion was approved yesterday, May 12, 2025:

"Whereas 29831 Irish School Road in the Municipality of Chatham-Kent is a property approximately 800 metres from the Town of Dresden;

And Whereas the property contain small fill areas used for historic local landfill purposes, and the property has never been properly studied or zoned for any significant landfilling use;

And Whereas the current property owners are attempting to create a new recycling and landfill facility for millions of tonnes of waste, which would result in hundreds of trucks travelling through towns and communities in the area;

And Whereas this approach has been strongly opposed by Council, the Community, neighbouring Indigenous Nations and many other voices, due to impacts to the environment, our homes, the safety of our families and children, and the fabric of our communities;

And Whereas the Provincial government has proposed Bill 5, which includes a section removing the obligation for a full Environmental Assessment for this new landfill and recycling facility;

And Whereas if this limited, historic local landfill use on the edge of Dresden can be expanded into a massive landfill and recycling facility, then this can happen anywhere;

And Whereas there are likely hundreds of properties across the Province that may have had limited, historic waste uses, which could also face this threat;

And Whereas Bill197 established a veto for Municipalities within 3.5 kms of a new landfill, which reflected the need for local government and community approval of landfill sites;

And Whereas the approach being taken for this property disregards the importance of our rural communities, and local voices, in determining appropriate landfill sites within their communities:

Now Therefore to ensure that other Municipal Councils and communities know about what is happening in Dresden, and the potential risk to their community if this approach is taken by the Province, Council requests that the Mayor's Office write a letter to all other Ontario Municipalities, AMO, ROMA and FCM:

- Advising them of this issue and the risks to their community if a similar approach is taken for other historic landfill properties; the possibility of the Ontario government setting a precedence and
- Requesting their support in opposing this approach and ensuring that full Environmental Assessments are required for all landfills and that municipalities have a strong voice in determining appropriate locations for landfills in their communities."

## **Policy Update - Provincial Budget Priorities**

This afternoon, Ontario's Minister of Finance introduced the 2025 Ontario Budget, <u>A Plan to Protect</u> Ontario.

Today's budget paints a challenging economic outlook for the province with much larger deficits and lower housing starts now projected over the coming years. While we're facing significant economic uncertainty, the government's plan is a solid first step in addressing the challenges posed by U.S. tariffs.

AMO has been working hard to help its members understand how the rapidly changing economic landscape will impact municipalities. We recently released a <u>2025 Pre-Budget Update</u> building the case for strategic investments in municipal infrastructure and social housing to stimulate the economy in the short-term and support long-term economic productivity. We look forward to working with the provincial government to bring this message to federal leaders.

We are pleased that today's budget includes some important actions for our communities, particularly through new investments in infrastructure, economic development and primary care. However, these uncertain times have only escalated the need to address long-standing municipal priorities. AMO remains committed to our urgent call to revisit the provincial-municipal fiscal framework with the provincial government.

"In the face of global economic and political uncertainty, municipalities stand united with provincial and federal governments. Today's provincial budget investments in critical water infrastructure and industries impacted by tariffs are an important first step in helping Ontario weather the current economic storm. AMO and municipalities are ready to work together to advance solutions that will save jobs in the short-term while building enduring economic prosperity across the province" – Robin Jones, President of the Association of Municipalities of Ontario (AMO)

Budget Highlight: Responding to Trade and Tariff Uncertainty

- A new \$40M Trade-Impacted Communities Program (TICP) to help communities and local businesses disproportionately affected by the trade and tariff uncertainty
- A range of investments to diversify Ontario's economy and support local economic development. Highlights include:
  - An additional \$600M for the Invest Ontario Fund to create jobs and attract investment
  - \$1.3B over three years to enhance and expand the Ontario Made Manufacturing Investment Tax Credit
  - \$50M over three years to create the Ontario Together Trade Fund (OTTF) to help local businesses develop new markets and re-shore critical supply chains
- Investing in skills training to improve Ontario's labour market, including:
  - An additional \$1B over three years for the Skills Development Fund
  - \$20M to mobilize new training and support centres for laid-off workers, including those impacted by U.S. tariffs
  - An additional \$50M for the Better Jobs Ontario program, including a fast-track stream for job seekers in trade-impacted sectors

#### Budget Highlight: Infrastructure & Housing

- Additional \$400M through the Municipal Housing Infrastructure Program (MHIP) and the Housing Enabling Water Systems Fund (HEWSF) to build the local infrastructure needed to enable new housing
- \$50M over five years through Invest Ontario to grow capacity in modular housing construction
- Up to a further \$5B in funding to the Building Ontario Fund (BOF) to co-invest in priorities like municipal infrastructure, long-term care, energy infrastructure, and affordable housing
- Increasing annual funding for the Connecting Links Program from \$30M to \$45M to support municipalities to maintain critical road infrastructure

#### Other Commitments of Interest

- Reconfirming the additional \$50M increase to the Ontario Municipal Partnership Fund, bringing the total envelope to \$600M by 2026
- Confirming the previously announced \$20M over two years through the Rural Ontario Development program
- Investing in police training and equipment, including \$1B to expand and renovate two training facilities, \$57M for two new police helicopters, and \$6M through the Preventing Auto Theft Grant
- \$300M over four years to support Primary Care Teaching Clinics, increasing Primary Care Action Plan investments to \$2.1B
- Adding \$260M over three years in the Learn and Stay Grant to increase the number of health care professionals in underserved communities

- Making the cut to the Gasoline and Fuel Tax rate permanent. This should not impact the portion of the Gas Tax that is allocated to municipalities for public transit
- \$500M in a new Critical Minerals Processing Fund to provide strategic financial support for projects that will accelerate the province's critical minerals processing capacity

### **Provincial Government Launches OPP Billing Review**

In a letter to impacted Mayors and CAOs sent yesterday, the Ministry of the Solicitor General announced the launch of a review of the OPP cost recovery model. The review is expected to be finalized in time to inform the issuing of 2026 annual billing statements, with opportunities for engagement with municipalities in June.

AMO understands the impact of rising police costs on municipalities across Ontario, including both those with OPP and municipal police services. AMO looks forward to working closely with SOLGEN on this review and putting it within the context of the need to reform the broader provincial-municipal fiscal relationship.

#### Provincial Strong Mayor Powers Training

Responding to strong AMO advocacy for provincial guidance, the Ministry of Municipal Affairs and Housing is <u>offering training on the strong mayor powers framework</u> that was recently extended to 170 more municipalities.

Two training sessions will be offered in the coming weeks, targeted to elected officials, clerks, treasurers and CAOs.

### Bill 6, Safe Municipalities Act, Homelessness Encampments Legislation

## A4b

Today, AMO sent a letter to Minister Flack, sharing AMO's submission on Bill 6, Safer Municipalities Act, 2025.

The legislation includes two key components. If passed by the legislature, a new *Restricting Public Consumption of Illegal Substances Act, 2025* would further prohibit the consumption of illegal substances in public places. Additionally, amendments to the *Trespass to Property Act* would add aggravating factors to be considered by courts should someone be convicted of a charge under the act.

AMO agrees that urgent action is needed to address the 1400 encampments that now exist in all parts of Ontario across urban, rural and northern communities. While the new police and court tools may be helpful in specific circumstances, we cannot only enforce our way out of the homeless crisis. AMO will continue to advocate for investments in the root causes of homelessness, including deeply affordable housing, access to mental health and addiction supports, and improvements to income security.

#### New Federal Minister of Housing and Infrastructure

Today, AMO <u>sent a letter to Minister Robertson</u> congratulating him on his appointment as the Minister of Housing and Infrastructure. AMO will continue working with partners at the province and the Federation of Canadian Municipalities to convey the unique role that Ontario municipalities play. We will also look forward to advancing meaningful solutions to improve the current tools and systems municipalities have to build infrastructure and housing, including social housing.

#### **Ontario Launches Trade-Impacted Communities Program**

As announced in the 2025 Ontario Budget, the Ministry of Economic Development, Job Creation and Trad is launching a new <u>Trade-Impacted Communities Program (TCIP)</u> to provide up to \$40 million in funding to support communities and local industries that are facing economic challenges arising from ongoing US trade disruptions. Stream 1: Community Economic Development is open for applications on a continuing basis while funding is available. Stream 2: Transformation projects will be open until September 11, 2025.

This email is being sent to the attention of Premier Doug Ford, Honourable Peter Bethlenfalvy, Honourable Trevor Jones, , MPP Brian Saunderson, MPP Paul Vickers, MPP Nina Tangri, Grey County and to all municipalities in Ontario, with a request to support the following Resolution that was passed by Council of the Town of The Blue Mountains at the May 14, 2025, Special Meeting of Council:

WHEREAS the Town of The Blue Mountains boasts a robust agricultural sector and a thriving agritourism industry, with numerous local cideries contributing significantly to the local economy, employment, and tourism;

AND WHEREAS Ontario's craft cider industry is experiencing substantial growth, with over 60 craft cideries across the province, many of which are situated in rural communities and utilize 100% Ontario-grown apples and are 100% made in Ontario, thereby supporting local agriculture and local economies;

AND WHEREAS under the current provincial tax structure, cider is officially classified and taxed at the same rate as imported wine which results in higher markups and taxes compared to craft beer, despite cider's comparable production processes and market positioning;

AND WHEREAS this tax disparity places Ontario's craft cider producers at a competitive disadvantage compared to craft brewers, despite the fact that Ontario cider utilizes 100% Ontario-grown apples and is 100% made in Ontario;

AND WHEREAS the Ontario Craft Cider Association (OCCA) has been actively advocating for a tax structure that levels the playing field between craft cider and craft beer, recognizing the potential for job creation, economic growth, and the promotion of local agriculture;

AND WHEREAS the Town acknowledges and appreciates the Province's investment in marketing and promotional support for the craft cider industry, but maintains that long-term sustainability and competitiveness for Ontario cider producers requires an adjustment to the underlying tax framework;

AND WHEREAS this motion is meant to support, not oppose, initiatives for fair taxation of the Ontario Craft Cider industry the Province of Ontario may be considering.

THEREFORE BE IT RESOLVED THAT the Council of the Town of The Blue Mountains:

- 1. Supports the efforts of the Ontario Craft Cider Association in advocating for a fair and equitable tax structure for Ontario-made craft cider.
- 2. Urges the Province of Ontario to review and amend the current tax regulations to align the tax rate of craft cider with that of craft beer, thereby fostering a more balanced and supportive environment for local cider producers.

- Acknowledges the Province of Ontario's recent investment in marketing initiatives for the cider sector, while calling for complementary reform of the tax and markup structure that continues to disadvantage cider producers relative to other craft alcohol categories;
- 4. Directs the Mayor to forward this resolution to the Premier of Ontario, the Minister of Finance, the Minister of Agriculture, Food and Rural Affairs, MPP Brian Saunderson, MPP Paul Vickers and MPP Nina Tangri and the County of Grey requesting their consideration and support.
- 5. Directs the Mayor to forward this resolution to all municipalities in Ontario, encourages other municipalities with vested interests in agriculture and agri-tourism to adopt similar resolutions, amplifying the collective voice advocating for the prosperity of Ontario's craft cider industry.

WHEREAS the Government of Ontario has introduced Bill 5: Protecting Ontario by Unleashing Our Economy Act, 2025, which proposes significant changes to environmental legislation, including the replacement of the Endangered Species Act, 2007 with the significantly weaker Species Conservation Act, 2025, and would grant the Premier and Cabinet unprecedented powers to override provincial and municipal laws – including laws that protect public health, farmland, and the natural systems that safeguard communities from extreme weather events; and

WHEREAS The Township of The Archipelago's strategic priorities include protecting and preserving our unique and high-quality natural environment, and delivering municipal services in a responsible, sustainable, cost-effective, and efficient manner; and

WHEREAS The Township of The Archipelago supports the goals of responsible economic growth and increased housing supply; and

WHEREAS nature is not red tape – it is the economic driver of our region, and is central to Canadian culture, identity, and economy; protecting nature is essential for building resilient communities and upholding the sovereignty and stewardship of Indigenous peoples; and

WHEREAS Bill 5 will undermine critical environmental, species, and heritage protection laws, introducing significant economic, environmental, social, and cultural uncertainty, endangering Ontario's 249 at-risk species, and potentially infringing on the legal and constitutional rights of the Ontario public – especially Indigenous communities that are disproportionately affected by such actions;

NOW THEREFORE BE IT RESOLVED that the Council for the Township of The Archipelago hereby

# AS

opposes the provisions in Bill 5 that would undermine environmental safeguards, Indigenous rights, or local planning authority, and urge the Province to withdraw the Bill; and

**FURTHER BE IT RESOLVED** that Council urges the Province of Ontario to pursue housing and infrastructure development through policies that maintain robust environmental protections and respect local planning regimes; and

**FINALLY BE IT RESOLVED THAT** this resolution be sent to The Honourable Doug Ford, Premier of Ontario; The Honourable Sylvia Jones, Deputy Premier; The Honourable Rob Flack, Minister of Municipal Affairs and Housing; The Honourable Todd McCarthy, Minister of the Environment, Conservation and Parks; The Honourable Prabmeet Singh Sarkaria, Minister of Transportation; The Honourable Stephen Lecce, Minister of Energy and Mines; The Honourable Graydon Smith, MPP Parry Sound-Muskoka; The Association of Municipalities of Ontario (AMO); The Federation of Northern Ontario Municipalities (FONOM); The Northwestern Ontario Municipal Association (NOMA); and all Ontario municipalities; Chief Adam Pawis, all Township of The Archipelago Ratepayer Associations; and to other environmental organizations.

Dear Michael Mikael:

On behalf of the Ministry of Infrastructure, I would like to thank you for attending the 2025 Rural Ontario Municipal Association Conference. It was a pleasure to meet with you and your delegation.

As part of the Ministry of Infrastructure's (MOI) disposition process, as outlined in the Realty Ontario Directive, the Essa - Angus Tree Seed Plant surplus property has been assessed and circulated internally (through Stage 1 and 2 circulation) for potential use. As a next step, select entities, including the municipality, will have a chance to express interest during stage 3 circulation. If no interest is expressed at that stage, the property will be made available on the open market.

Our government remains committed to implementing a more efficient process for selling government buildings and properties that are no longer required for program delivery. The disposition process of surplus properties, launched in 2018, is a key component of the broader restructuring of the General Real Estate Portfolio.

The Province of Ontario is investing nearly \$2.3 billion in housing and communityenabling infrastructure as part of its over \$200 billion capital plan to build critical infrastructure and support growing communities. This funding is being delivered through the Housing-Enabling Water Systems Fund (HEWSF) and the Municipal Housing Infrastructure Program (MHIP), complementing existing provincial investments such as the Building Faster Fund (BFF) led by the Ministry of Municipal Affairs and Housing.

Through HEWSF, the province is investing nearly \$1.3 billion, which includes \$120 million from the BFF to assist small, rural, and northern municipalities without housing targets. In its first intake, HEWSF allocated \$970 million to 54 municipal water projects across 61 municipalities. To address oversubscription and expand funding opportunities, the government launched a second intake, which has now allocated \$325M to another 23 municipal water projects. In total, these 77 water infrastructure projects will enable municipalities to build approximately 600,000 new homes. Notably, the Ontario government is investing \$700 million through HEWSF to help build up to 160,000 new homes in 54 small, rural and northern municipalities without provincially-assigned housing targets.

Building on this, the 2024 Ontario Budget introduced MHIP, a \$1 billion program to support core infrastructure projects that unlock housing opportunities and promote growth. Under MHIP, Ontario is investing \$400 million in 58 projects across 60 municipalities through the Housing-Enabling Core Servicing (HECS) Stream. This stream focuses on constructing, repairing, and expanding essential assets such as roads, bridges, and culverts. In addition, the government announced the \$175 million Health and Safety Water Stream to help municipalities and First Nations address aging and at-risk water, wastewater, and stormwater infrastructure. Applications for this stream will open on April 17, 2025 and will close on June 26, 2025.

Ontario recognizes that upgrading community infrastructure is vital to support a growing population as well as to provide dependable services people rely on. It also recognizes that the need for municipal infrastructure investment is far from fully met. We encourage all municipalities to call on the federal government to request more infrastructure funding to help address local needs of municipalities across the province.

Thank you again for meeting with the Ministry of Infrastructure. I look forward to continuing to work with you in the future.
