Elise Dostal briefly explained to Council that AMO and LAS have partnered with Service Line Warranties of Canada to offer residents of Ontario municipalities a sewer and water lateral warranty service. She described the program as one that offers external sewer and water line warranty to homeowners of single family home dwellings to assist with their responsibilities for any repair(s) or replacement of their utility service lines at a reasonable cost. She stated that currently Service Line Warranties of Canada has partnered with many other municipalities and explained that she is looking for municipal endorsement by Council so that residents can see that it's a creditable program.

Mayor Macdonald thanked Elise for her presentation.

Re: Farmland Tax Rate Reduction John Morrison, Simcoe County Federation of Agriculture

John Morrison stated that farmlands are currently taxed at 25%. He expressed concern about the financial burden that this places on farmers. He advised Council that he will be making a delegation to County Council in the near future and would like to see Essa Council support the request of the Simcoe County Federation of Agriculture for a reduction in the farmland tax rate at the County level to from 25% to 20% in 2020.

Council thanked Mr. Morrison for his presentation and requested that the Manager of Finance provide a Staff Report for Council's consideration at the next meeting which would outline the impact on Essa.

WHEREAS prenatal alcohol exposure is the leading preventable cause of birth defects, such as physical and mental disability and behavioural and/or learning challenges; and

WHEREAS the exact number of people who have FASD is unknown, but it is estimated that 2 to 3 percent of the population are born with effects of prenatal alcohol exposure annually; and

WHEREAS the estimated cost of FASD in Canada is \$4 billion per year covering education, health, social services and justice costs; and

WHEREAS about half of all pregnancies are unplanned meaning developing fetuses are inadvertently exposed to alcohol; and

WHEREAS people around the world began observing International FASD Awareness Day on September 9 each year beginning in 1999, in order that on the ninth day of the ninth month of the year, the world will remember that during the nine months of pregnancy it is important to abstain from alcohol; and

WHEREAS the good health and well-being of the people of Essa are enhanced by the support of a national effort to educate about and prevent FASD through the Simcoe County FASD Prevention Committee, part of the Simcoe County FASD Initiative;



The Chair thanked the applicant and candidate and advised that the committee will take 15 minutes to deliberate.

DELIBERATION

The Committee deliberated in private in accordance with subsection 88.33 (5.1) of the *Municipal Elections Act.*

The committee returned to the meeting room.

DECISION OF COMMITTEE RENDERED FOR APPLICATION NO. 1

The Chair advised that following deliberation, the committee is prepared to issue an oral decision. A Notice of Decision containing written reasons will be provided at a later date.

The Chair stated that there does not appear to be a violation of the *Municipal Elections Act* relating to the election finances of candidate Keith White. The costs of all flyers and brochures used by candidate White appear to be included in the financial statement as filed. The number of flyers (3) identified by the applicant is corroborated by the candidate's submission of a detailed spreadsheet identifying individual payments. The committee is therefore rejecting the application for a compliance audit.

NOTICE OF DECISION SOUTH SIMCOE JOINT COMPLIANCE AUDIT COMMITTEE

Established under Section 88.37 (1) of the Municipal Elections Act, 1996

A meeting of the South Simcoe Joint Compliance Audit Committee was held on May 10, 2019 to consider the applications submitted by Mr. Archie Duckworth concerning the election campaign finances relating to the 2018 Municipal Election for the following:

- Keith White Candidate, Councillor Ward 1 (Application No. 1)
- Keith White Third Party Advertiser (Application No. 2)

Upon consideration of the testimony and materials submitted by the applicant and candidate, beginning with Application No. 2, the committee made the following decisions:

Application No. 2

- 1. With respect to the matter of Keith White as a Third Party Advertiser, it is the view of the committee that:
 - Under section 88.6 (5) of the Municipal Elections Act, a candidate whose nomination
 has been filed under section 33 is not eligible to file a notice of registration as a third
 party advertiser. Keith White was a certified candidate in the 2018 Municipal Election
 and as such was not eligible to file a notice of registration as a third party advertiser;
 - Under section 88.35 (1) of the *Municipal Elections Act*, an elector who believes on reasonable grounds that a registered third party who is registered in relation to the election in the municipality has contravened a provision of the Act relating to campaign finances may apply for a compliance audit of the campaign finances of the registered third party in relation to third party advertisements. The Township of Essa did not have any registered third parties in the 2018 Municipal Election.
- 2. The application to request an audit of the financial statements of candidate Keith White as a registered third party is out of order as it is not in compliance under sections 88.6 (5) and 88.35 (1) of the Act as noted above and therefore, **the committee rejects the application**.

Application No. 1

- 1. With respect to the matter that Keith White's financial statement does not reflect all costs that were incurred for flyers and/or brochures, it is the view of the committee that:
 - all costs of all flyers and brochures used by candidate Keith White appear to be included in the candidate's financial statement as filed;

- the number of the flyers (3) as identified by the applicant is corroborated by the candidate's submission of a detailed spreadsheet of election expenses identifying the individual payments for the printing and mailing of the flyers;
- no evidence was presented of any other campaign advertising which was not properly recorded; and
- the cost for printing and mailing of flyers is an eligible expense under the *Municipal Elections Act.*
- 2. With respect to any other allegations regarding the content and timing of the flyers, it is felt that this matter is beyond the scope of the committee in dealing with the election campaign finances of a candidate.
- 3. There does not appear to be a violation of the *Municipal Elections Act* relating to election campaign finances and therefore, **the committee rejects the application for a compliance audit.**

Pursuant to section 88.33(9) of the *Municipal Elections Act*, the decision of the committee may be appealed to the Superior Court of Justice within 15 days after the decision is made.

The meeting was called to order and the minutes of April 24th accepted as circulated.

Moved by Brandy Rafeek and Seconded by Ron Henderson "Be it resolved that the minutes of April 24th be accepted". Carried.

Colleen reviewed the Terms of Reference with the Committee and welcomed input from the Committee as they should be bringing forward ideas as they feel comfortable. Willy was informed of the Conflict of Interest policy. The policy may be brought forward again at a future meeting to ensure that all Members are well informed. All Members were to acknowledge receipt and understanding.

Colleen informed the Committee that Parks Staff has been running down the list from the minutes of the last meeting to get parks in good shape. Items mentioned by baseball associations are being addressed. At issue still is the requested pitching mound for Baxter. A pitching mound was requested by the Ivy Assoc'n and also Angus Minor Ball for their select team. Council asked that this matter be researched to know if it was possible to allow a permanent pitching mound to be built in Baxter.

Pitching Mound in Baxter

Willy felt that putting a mound in Baxter is not possible since the diamond in Baxter is too small. It was mentioned that it is not a good idea for softball or slo-pitch teams to be playing on diamonds with mounds as the distance between bases, and the distance between the pitcher's plate and home plate is shorter than for hard ball. The distance between the outfield fence and home plate is 275 feet. The radius for the fence was taken from home plate when the diamond was constructed, but for older kids and adults, the radius should be taken from the pitcher's mound to provide for a larger field. The outfield can't be extended in Baxter due to the position of the lights around the outfield. Would a portable pitching mound be a solution?

A comment was made about the mound becoming a tripping hazard.

Some Committee Members felt that the older teams/hard ball could play out of Angus and suggested that Staff look to shuffling around playing fields amongst teams.

The new Bob Geddes baseball park in Angus has a pitching mound.

Colleen would continue to summarize info collected from Staff from national organizations and report back to Council noting that there did not seem to be interest here to support the request.

Future Plans

There seems to be a lot of interest in lights and converting to LED from the Committee in keeping with resolutions of the last meeting. If lights, then we could charge a higher rental rate for use of diamonds when lights are on. A possible new revenue stream.

When looking at space for new baseball diamonds, Brandy asked Staff to report on the sustainability of the facility and to look at trends and demographics.

Staff was asked to look into providing opportunities for basketball. Further info would be brought back to the Committee before a resolution is considered.

Programs

Colleen introduced Sueanne who organizes programs for the Township as the Program Coordinator. She asked Sueanne to speak to programs.

- Sueanne reported that pickleball is very popular, getting requests from seniors for playing opportunities
- Tennis did not go, tried in the winter in the gym, can try again?
- Will be trying badminton Special Olympics does this
- Sandie asked about volleyball? Create teams mixed
- Sandie suggested referring to other municipalities and Sueanne said that, I get good ideas from other municipalities, we work well together
- Hard to get attendance in Thornton
- Sandie asked, what about thai chi and line dancing?
- Brandy how about trying basketball, people from Baxter driving to Bradford, Barrie and Base; Can have open gym/drop in/ set time or league play





Deputations

Hockey associations were welcomed to the meeting to introduce themselves. None attended although the Angus Minor Hockey Assoc'n and Essa Hockey sent regrets.

Colleen relayed a message from Essa Hockey and noted that Staff recently met with the Board of the Thornton Minor Hockey Assoc'n. Sandie was contacted by the AMHA who asked that ice be put in, in Angus for September 13th.

Essa Hockey: has 27 ice hockey teams and runs ball hockey in Thornton for all ages of players. A new website and can take registrations and are well organized. Want to work with Essa Twp and willing to run leagues of more than just hockey.... pickleball, baseball, and broomball. Would love to attend another meeting when they are available.

General Discussion on hockey

Essa has an established policy on booking and it was explained to the Committee (Minor hockey then adult gets to book by end of May, then others). The Committee did not express an interest in recommending any changes. The Committee did not want to bump minor boys for tournaments/nor Stallions.

The Committee supported last year's decision to make ice for mid-September.

The Committee supported the previous decision on Timbit hockey.

Sandie asked for clarification on the cancellation policy. Sherrie: once taken they are on the hook for this, can't give back, they can trade.

Open Discussion

WHEREAS Council of the Corporation of the Township of Essa deems it advisable for the safety of its inhabitants and orderly traffic flow within the Township to prescribe a certain rate of speed on the 20th Sideroad by further amending By-law 98-10; and

NOW THEREFORE BE IT RESOLVED THAT Council of the Corporation of the Township of Essa hereby enacts as follows:

1. That By-law 98-10 be and is hereby amended to include the following rate of speed on the 20th Sideroad from Centennial Park to County Road 56:

HighwayFromToRate of Speed20th SideroadCentennial ParkCounty Road 5660 km per hour

2. That this By-law shall come into force and take effect from the final day of passing.

A By-law authorizing the Mayor and Clerk to execute the Wildland Fire Fighting Services Agreement with the County of Simcoe; and to repeal By-law 99-53.

WHEREAS the *Fire Protection and Prevention Act* 1997, S.O. 1997, c. 4 allows the Council of a municipality to pass By-laws for regulating fire prevention, including the prevention of the spreading of fires; and

WHEREAS the *Municipal Act*, 2001, as amended, permits a municipality to enter into an Agreement with one or more municipalities to jointly provide for any matter which all of them have the power to provide within their own boundaries, and the municipality may provide the matter in accordance with the Agreement anywhere that any of the municipalities have the power to provide the matter; and

WHEREAS the County of Simcoe is the owner of certain tracts of land that form part of the Simcoe County forest that are located within the Township f Essa's geographic boundaries; and

WHEREAS at its meeting of August 18, 1999, Council passed By-law No. 99-53 authorizing the execution of a Wildland Fire Fighting Services Agreement with the County of Simcoe, which details the terms by which the Township of Essa will provide such services for the County of Simcoe forests located within the geographic boundaries of the Township of Essa; and

WHEREAS the County of Simcoe and the Township of Essa wish to terminate the Original Agreement and set out new terms and conditions under which the Township of Essa Fire Department will provide fire services for the County forest;

NOW THEREFORE BE IT RESOLVED THAT Council of the Corporation of the Township of Essa hereby enacts as follows:

- 1. That the Mayor and Clerk are hereby authorized and directed to sign the Wildland Fire Fighting Services Agreement, a copy of which is attached hereto and forms part of this Bylaw.
- 2. That By-law 99-53 be and is hereby repealed.
- 3. That this By-law shall come into force and effect from and after the final passing thereof.

READ A FIRST, AND TAKEN AS READ A SECOND AND THIRD TIME AND FINALLY PASSED on this the 5th day of June, 2019.

WILDLAND FIREFIGHTING AGREEMENT

FOR SIMCOE COUNTY FORESTS

Dated the ____ day of _____, 2019 (the "Effective Date")

BETWEEN:

THE CORPORATION OF THE TOWNSHIP OF ESSA

(the "Participating Municipality")

and

THE CORPORATION OF THE COUNTY OF SIMCOE (the "County")

WHEREAS:

- A. The Municipal Act, 2001, as amended, permits municipalities to enter into agreements for the joint administration of firefighting;
- B. The Participating Municipality provides fire services within its geographic boundaries;
- C. The County is the owner of certain tracts of land that form part of the Simcoe County forest system (the "County Forest") that are located within the Participating Municipality's geographic boundaries;
- D. The parties entered into an agreement dated November 1, 1999 which details the terms by which the Participating Municipality will provide wildland firefighting services for the County Forest(s) located within Participating Municipality's geographic boundaries (the "Original Agreement");
- E. The parties wish to terminate the Original Agreement and set out new terms and conditions under which the Participating Municipality will provide fire services for the County Forest;

NOW THEREFORE WITNESSETH that in consideration of the above and the covenants contained herein, the parties agree as follows:

- 1. Definitions
 - a. "Fire Chief" means the person (or their designate) appointed by the Participating Municipality as the head of the fire department.

- **b.** "Fire Co-ordinator" means the person appointed by the Fire Marshal to co-ordinate a Mutual Aid Plan.
- **c.** "Host Municipality" means a municipality with care and control of a Wildland Equipment Cache(s) as listed in Appendix A.
- **d.** "Mutual Aid Plan" means a program to provide or receive assistance in the case of a major emergency in a municipality, community or area.
- e. "Wildland Equipment Cache" means a collection of specialized wildland firefighting equipment used to extinguish wildland fires.

2. Termination of Original Agreement

The parties agree that the Original Agreement will be terminated as of the Effective Date of this Agreement and the rights and obligations of the parties with respect to wildland firefighting services shall be conducted in accordance with this Agreement.

3. Municipal Fire Services

The Participating Municipality will respond to calls for fire services, as its resources reasonably permit, to fight and extinguish fires occurring in all County Forests located within the Participating Municipality's geographic boundaries.

The Fire Chief will have full authority to manage the fire until all units have returned to their stations or the fire has otherwise been declared out by the Fire Chief.

The Host Municipalities listed in Appendix A will be responsible to check, inspect and repair the equipment contained in the applicable Wildland Equipment Caches.

4. Location of County Forests

The County will work with the Participating Municipality to provide up-to-date County Forest property information including maps of the County Forests, in a mutually agreeable form.

5. Wildland Equipment Caches

The County will provide caches of wildland firefighting equipment for use by the Participating Municipality and other municipal fire departments within the County. Each equipment cache will contain the items listed in Appendix A and will be



stored by the Host Municipalities listed in Appendix A. The County will be responsible to repair or replace items within each Wildland Equipment Cache on an 'as-needed' basis as identified by the Host Municipalities. The County will cover the costs associated with repair and replacement of such equipment.

Notwithstanding their location, all Wildland Equipment Caches will be available to any municipality, including the Participating Municipality, in any emergency. If multiple municipalities require equipment at the same time, the Fire Co-ordinator will resolve such conflict based on priorities of fire response.

6. Specialized Training Costs

The County will cover the cost for firefighters to attend the SP103 course up to a maximum of \$2,500.00 annually for all Participating and Host Municipalities combined. The SP103 course is a 2-day course for municipal fire departments designed to provide firefighters with basic wildland firefighting knowledge and skills. Priority attendance will be offered to firefighters from Host Municipalities followed by other interested firefighters from Participating Municipalities.

7. Fees

In consideration of the Participating Municipality responding to calls pursuant to this Agreement, the County shall pay to the Participating Municipality the current fee rate as established by the Ministry of Transportation for highway calls or the Ministry of Natural Resources & Forestry (MNRF), if applicable, whichever is higher.

If other municipalities or provincial agencies, including but not limited to the MNRF provide fire assistance pursuant to a mutual aid agreement, the County will pay the fees set out above with respect to all fire apparatus or support units including all on or off road fire department vehicles as well as any MNRF land or air support vehicles, as determined by the Fire Chief. The Participating Municipality will be responsible for forwarding any fees collected from the County to the other responding municipalities or provincial agencies, including but not limited to the MNRF.

The County shall pay for any equipment rented or purchased to assist in extinguishing a fire if such equipment rental or purchase has been authorized by the Fire Chief.

8. Termination

This agreement may be terminated by either party upon the giving of thirty (30) days written notice to the following addresses:

Otherwise, this agreement shall continue from year to year until so terminated.
